Happy Holidays to you and your family. I hope you find time in this most busy season for the final two SARL events of the year. Let's also hope the roads stay dry and the weather moderate for these runs. Each race is very unique and special to the San Angelo.

The first event is Run, Run Rudolph 2 ½ mile run/walk starting at 5:30 p.m. on Saturday, December 15<sup>th</sup>. This is a FREE run/walk under the Concho River lights. We have approval of the Concho Christmas Lights Committee for this run/walk. They will keep the Concho River road closed to traffic, so that you can enjoy the lights even more.
